- Restricted stock unit (RSU) vests ratably over three years, one-third on each of the first, second and third grant date anniversaries. RSUs are payable in stock only.
- Vesting of the Performance Awards granted May 29, 2007 (reported on a Form 4 on May 31, 2007) at 62.06 % of target based upon U. S. Steel's total shareholder return v. that of peer group of companies over a 3-year period. (Performance Awards granted after 2008 will be reported on Form 4s only when, and if, such grants should vest.)
- Option grant vests ratably over three years, one-third on each of the first, second and third grant date anniversaries.
