**Explanation of Responses:**

- This line reflects the grant of restricted stock units (RSUs). RSUs vest ratably over three years, one-third on each of the first, second and third grant date anniversaries. RSUs are payable in stock only.
- This line reflects the tax withholding on the vesting of TSR-based performance RSUs that vested on February 22, 2022. TSR-based performance RSUs were granted on February 26, 2019 and vested based upon the performance of U. S. Steel's common stock performance vs. that of a peer group over a three-year period. The shares were earned under this award on February 23, 2021, as reported on a previous Form 4.
- This line represents performance-based RSUs that were granted on February 26, 2019, and vested on February 22, 2022. ROCE-based performance awards vest upon the achievement of return on capital employed (ROCE) against pre-set performance targets.
- This line reflects the tax withholding on the vesting of ROCE-based performance RSUs that vested on February 22, 2022.
- This line reflects the tax withholding on the vesting of RSUs that were granted on February 23, 2021.
